On each envelope name and address of firm shall be written in block letters. The envelope should be addressed to the Associate Dean, NVC, Nagpur. Quotation should be submitted in the prescribed quotation form provided by the University. Copy or Xerox will not be accepted.
- 2. Quotations shall be opened as far as possible in the presence of all firm holders and committee members of NVC, Nagpur. Sealed envelope No.3 shall be opened first. It must contain two envelopes Envelope No. 1 & 2. Envelope No 1 is technical quotation which will be opened first and if it contains all the papers required then envelope No. 2, containing the schedule of rates will be opened. If it is found that all the papers are kept together in a single envelope ignoring instructions given above, the quotation shall be rejected forthwith.
- 3. EMD EXEMPTION: The bidder seeking EMD exemption, must submit the valid supporting document for the Relevant category with the quotation.
